The model, which is grounded in primary care and includes patient/citizen engagement in goal setting, has delivered remarkable improvements in each of the dimensions of the Quadruple Aim (Hildebrandt et al 2015, Schubert I et al 2014, 2016, Groene O et al 2017, Nolte E et al 2016, McClellan et al 2017).

Why you need to attend

- A population that is living longer with increasing co-morbidities and complex health and social care needs
- A typically fragmented system in which incentives and funding models have led to adversarial relationships

Drive culture change in healthcare

Learn practical applications and receive actionable feedback from faculty and peers

A misalignment of payment and incentive structures typically results in unnecessary duplication of services, poor care coordination and suboptimal health outcomes. Health and care systems are seeking to address this increasing problem.

System leaders are beginning to arrive at the same conclusion: that they will best achieve their goals by operating as a single system, which requires coordination, transparency and a focus on outcomes.

New relationships, functions and incentivisation models are required to coordinate and harness the information necessary to assess or improve the complex care pathways that are characteristic of modern health systems.

This particularly affects the chronically ill and vulnerable (e.g. in care transitions out of hospital, for example), but also affects patients undergoing elective surgery who would otherwise benefit from a better alignment of services.

To improve health systems, the incentive structure embedded in current service organisation must change.

A new approach is needed that focuses on improving population health, incentivising prevention and increasing the value of care delivery.

Such an approach requires redesigning health systems, building appropriate data systems to capture outcomes of relevance to patients, and offering the right incentives for providers to work towards a common goal - ideally working towards a system that promotes health, rather than responds solely to ill-health.

Our course faculty has an unparalleled track record of practical implementation of these models internationally, borne out of a deep understanding of the mechanisms needed to move towards contracting for outcomes, and can demonstrate its effectiveness.

“ After 10 years of implementing the accountable care model “Gesundes Kinzigtal” life expectancy increased by 1.5 years compared to matched controls.

An immersive and interactive course

Putting accountable care systems into practice requires a collaborative effort of all stakeholders of that system - providers, commissioners, industry, and regulators.

We encourage the participation of teams reflecting different responsibilities (quality, contracts, finance, implementation) to get the most out of the course.

The course demands active engagement for participants to truly transform their abilities and approach to healthcare

Participants are encouraged to apply from all sectors: the NHS, local government, the charitable and voluntary sector, private and independent sectors as well as government. The course is interactive and learning will be shared across members, steered by innovative examples from around the world.

We encourage participants to come prepared with projects and programmes they are working on to bring fuel to the debate as well as providing opportunities for each member to apply and test their learning.

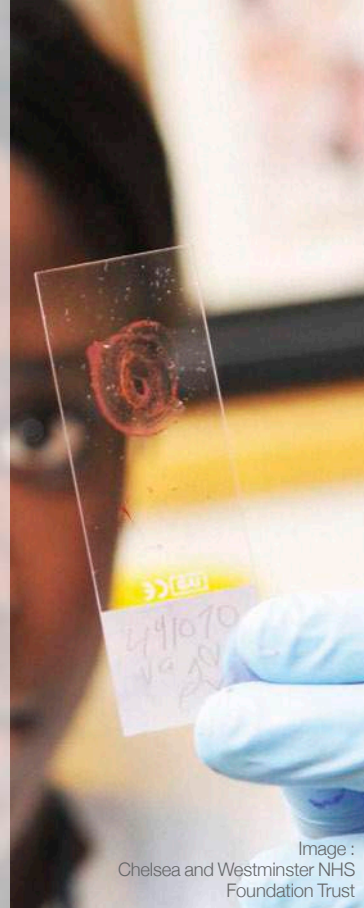

Day one

The first day will set the scene for the course: understanding the system drivers for accountable care, identifying key elements of accountable care systems and appraising their impact.

Keynote presentations and small group work on the following topics:

- **Best in practice international accountable care examples**
- **Managerial and policy perspectives**
- **Appraising evidence and accountable care impact**
- **Exploring new business models for industry**

Day two

The second day of the course will address questions regarding the implementation of accountable care systems: what are possible governance structures, contractual requirements, prerequisites for IT design, population health monitoring and improvement

Keynote presentations and small group work on the following topics:

- **Understanding the full cycle: governance, IT, population health, and changing cultures**
- **Deep dive - outcome assessment in accountable care systems**
- **Data analytics and intervention planning: current best in practice and a glimpse into the future**

Day three

The last day of the course is practical in nature: we will work with the material of the participants in small groups and on a one-to-one basis (we will protect Intellectual Property and ensure Non-Disclosure Agreements are in place as needed). This day will give the diverse audience the opportunity to benefit from the experience of the faculty.

Throughout this time, Nick has facilitated a range of action research projects, learning sets, workshops, exchange programmes and other events to support planners and purchasers of care in their role.

Nicholas is Managing Director of OptiMedis-COBIC UK. Nick, a doctor by background, has been instrumental in developing the principles and pioneering the practice of outcomes-based commissioning and accountable care in the UK. He has spent most of his career in the NHS working as a GP, a Director of Public Health and Chief Executive of the NHS Primary Care Trust in Milton Keynes and in the Department of Health's Strategy Unit working to the Secretary of State, Alan Millburn and Simon Stevens. He was the lead author of the Coronary Heart Disease National Service, awarded the Harkness Fellowship based at the Rand Corporation, Santa Monica, California and served as an Honorary Research Fellow in Primary Care at the University of Oxford.

Stephen is the Blue Cross of California Distinguished Professor of Health Policy and Management and Professor of Organization Behaviour at the School of Public Health and Haas School of Business at University of California-Berkeley where he also co-leads the Centre for Healthcare Organisational and Innovation Research (CHOIR) and the Centre for Lean Engagement and Research (CLEAR) in healthcare. From 2002 to 2013 he served as Dean of the School of Public Health at Berkeley. He is currently conducting research on patient engagement and the performance of accountable care organisations (ACOs) and on Lean applications in healthcare. He is an elected member of the National Academy of Medicine and a recent recipient of the AHA/HRET TRUST Visionary Leadership Award.
